#### 6. ACCIDENTAL RELEASE MEASURES

STOP LEAK IF YOU CAN DO SO WITHOUT RISK. DIKE OR DAM LARGE SPILLS. AVOID DIRECT DISCHARGE TO SEWER AND SURFACE WATERS. PUMP TO CONTAINER OR SOAK UP WITH NON-COMBUSTIBLE INERT ABSORBENT MATERIALS. #### 7. HANDLING AND STORAGE
