#### 4. FIRST AID MEASURES

**EYES:** FLOOD EYES WITH LUKEWARM (NOT HOT) WATER POURED FROM A LARGE GLASS 2 OR 3 INCHES FROM EYES. REMOVE CONTACTS. HAVE PATIENT BLINK AS MUCH AS POSSIBLE WHILE FLOODING THE EYES. CONTINUE FOR AT LEAST 15 MINUTES.

**SKIN:** REMOVE CONTAMINATED CLOTHES, FLOOD WITH WATER FOR 15 MINUTES.

**INHALATION:** MOVE VICTIM TO FRESH AIR. GIVE ARTIFICIAL RESPIRATION IF PATIENT IS NOT BREATHING.

**INGESTION:** DO NOT INDUCE VOMITING. IF PATIENT IS CONSCIOUS AND CAN SWALLOW, ADMINISTER MILK OR WATER.

#### 7. HANDLING AND STORAGE

**HANDLING:** FOLLOW ALL LABEL DIRECTIONS. INSTRUCT PERSONNEL ABOUT PROPER USE, HAZARDS, PRECAUTIONS, AND FIRST AID MEASURES. AVOID INHALATION, INGESTION, AND CONTACT WITH SKIN, EYES AND CLOTHING.
