#### 7. HANDLING AND STORAGE

**HANDLING:** FOLLOW ALL LABEL DIRECTIONS. INSTRUCT PERSONNEL ABOUT PROPER USE, HAZARDS, PRECAUTIONS, AND FIRST AID MEASURES. AVOID INHALATION, INGESTION, AND CONTACT WITH SKIN, EYES AND CLOTHING. **OTHER TOXIC EFFECTS:** BASED UPON INGESTION OF NTA IN LIFETIME FEEDING, NTA HAS BEEN SHOWN TO INDUCE TUMORS IN THE URINARY TRACTS OF RATS AND MICE. HOWEVER, ON A PRACTICAL BASIS AND ACCORDING TO GUIDELINES FOR CLASSIFICATION OF EXPERIMENTAL ANIMAL CARCINOGENS OF THE ACGIH, NTA OR TRISODIUM NITRILOTRIACETATE WOULD NOT BE CONSIDERED AN OCCUPATIONAL CARCINOGEN OF PRACTICAL SIGNIFICANCE.
